Anishnawbe Mushkiki is an Indigenous community—led, primary health care organization. Our employees collaborate and work in a fast-paced interprofessional community services team to achieve a common goal of improving the quality of health and life of all people in Thunder Bay and catchment area.

Anishnawbe Mushkiki empowers people to achieve optimal health and well-being through a holistic healthcare approach, modelling the Indigenous values of balance, respect and community interdependence. We operate a primary care clinic, chronic disease management and prevention, traditional wellness, cultural programs, health promotion programs, community development initiatives, and social support services in a culturally safe environment.

We have a unionized workforce and offer competitive compensation including the Healthcare of Ontario Pension Plan.

### **POSITION SUMMARY**

Under the direction of the Director, Health and Community Services, the Pre and Post Natal Health Programs Coordinator (RN) for Fetal Alcohol Syndrome Disorder (FASD) prevention, pre and postnatal programming and other health programs is responsible for strengthening the capacity of Indigenous individuals, families and communities to take increased responsibility for their own health and well-being. This position will work with community organizations to develop and deliver

culturally appropriately strategies and activities that will promote and engage a FASD prevention strategy, pre and postnatal support programs and other chronic disease prevention and education to Indigenous residents in Thunder Bay.

### **DUTIES AND RESPONSIBILITIES HIGHLIGHTS**

- Responsible for the development and coordination of the overall programming objectives and work plans for all Community Health Programs.
- Oversees development of the overall annual plan for Health Programs.
- Responsible to promote FASD prevention programs, pre and postnatal and other chronic disease prevention and education to Indigenous people in Thunder Bay, in accordance with Ministry funding guidelines, requirements and programming priority indicators.
- Facilitates weekly support and education groups for community members that are at risk for, or are managing, FASD.
- Prepares all materials required for workshops, including pre and post requirements.
- Screens clients for diabetes and those at risk through referrals and existing programming.
- Plans, coordinates and executes activities, through collaboration with in-house dietitian to deliver programming that promotes diabetes prevention awareness with end goal of behaviour modification.
- Coordinates and finalizes overall reporting for presentation to the Manager, Community Services, prior to the presentation to the funder.

# **REQUIREMENTS**

- Diploma/Degree in Nursing or in Public Health or related health care education or equivalency
- Minimum three years' related work experience
- Experience with pre- and postnatal clients, maternity or diabetes prevention and treatment is considered an asset
- Use of an automobile, valid driver's license and appropriate insurance are required
- Tuberculin (TB) Skin Test, satisfactory Criminal Record Check including Vulnerable Sector Screening Check
- Current CPR/First Aid certification is required
- Good computer skills and knowledge
- Superior organizational and time management skills
- Effective communication skills- verbal, written and electronic format
- Demonstrated ability to work effectively as a team member in a multi-disciplinary environment
- Proactive and able to work independently, with minimal supervision
- Sound decision making and problem-solving skills
- Knowledge and experience working with the Indigenous Community
- Knowledge and awareness of Indigenous culture and traditions is an asset

- Ability to speak the Ojibway and/or Cree languages is an asset
